This interactive panel presentation will provide strategies and tools for successful network business planning, which leads to network sustainability. Business planning has been identified as one of the top issues facing networks. The panel discussion will include an overview of business planning and a framework model to facilitate business planning. NCHN members on the panel will discuss their networks' business plan documents, how they were developed and how they are utilized in the management of the network. In addition, a seasoned grant writer will discuss the role of the Business Plan in seeking private foundation funding.

Rebecca Wilson is currently the Program Coordinator for the State Primary Care Office Program at HRSA in Rockville MD. State Primary Care Office grantees serve as a focal point for designating health professional shortage areas and increasing access to care and facilitate the coordination of

activities within a State that relate to the delivery of primary care services and the recruitment and retention of critical health care providers.

Prior to coming to HRSA, Rebecca attended graduate school at Georgia Southern University. Previously she held a position as a behavioral health counselor in a residential treatment facility in Georgia.

Network Sustainability through Viable Peer Networks

Daryl Bohlender, Vice-President, Clinical Network Services, Western Healthcare Alliance

Western Healthcare Alliance is one of the premier healthcare networks, and has distinguished itself through unique sustainability ventures. WHA's viable peer networks are also unique in terms of the value they provide and the sustainable programs they have developed. HEALTH INFORMATION TECHNOLOGY AND YOUR NETWORK – Bringing it All Together

Learn how you can add to your existing services to support your members with their successful implementation and attestation of Meaningful Use. All rural health care facilities are faced with the enormous task of implementing electronic medical records in their facilities, and networks are perfectly positioned to support them with their implementation and attestation. While networks do not have to add an entirely new service line to provide this support, there are several strategies that can be executed at low-cost and low-energy that will provide significant value to the members.

This presentation will provide attendees with a snapshot of what the 40 federally funded Rural Health Information Technology Network Development Grantees are working on. Additionally, the presentation will feature a panel of rural network directors who are currently working to support their members with their HIT needs and participants will learn how they can best provide support to their members. Tools and resources will be provided. Presenters will also discuss how offering this type of support can add to the value statement of the network.



Terry has directed The Center since its inception in 1990 as the Minnesota Center for Rural Health. Terry has more than 29 years experience working with rural health care providers and communities. He leads all of the federally funded projects at the Center. Terry serves as Chair of the National

Rural HIT Coalition and co-leads the HIT Regional Extension Center for MN and ND. He led the development of two rural health networks, the Community Health Information Collaborative (CHIC), a HRSA Office of Rural Health Rural Health Network grantee, and the Northern Lakes Health Consortium, a network of clinics, hospitals and long term care facilities in northeast MN. He twice served as president of the National Cooperative of Health Networks (2008 and 2010), and has worked with rural health providers in more than 35 states.



Terry is an adjunct professor at St. Scholastica and the University of Minnesota, Duluth Medical School. He received his Master of Public Administration from Shippensburg University and a Bachelor of Arts, History/Journalism from the University of Minnesota.



Sally has been with The Center since 2009 and coordinates educational events, including workshops, conference calls, webinars, and meetings. She also develops and distributes communication materials for programs and assists with public relations and marketing of The Center's

services. She provides staffing for Rural Health Innovations (RHI). She also provides support and educational resources to networks nationwide, and provides technical assistance to the Rural Health Information Technology Network Development (RHITND) grantees. She works with the Veteran's Administration at the state, regional and national level. She received degrees in political science and Spanish from the University of Wisconsin, Eau Claire and is pursuing her M.B.A. from the College of St. Scholastica.

Jack King is Executive Director of Northcentral Montana Healthcare Alliance, a collaborative consortium of 15 healthcare facilities organized in 2003. The Alliance was one of the 40 recipients of the HRSA HIT Network Development Grant Program. NMHA is a partner of the REACH Montana Telehealth Network. Jack has served on the NCHN Board of Directors since 2008, serving as Secretary in 2009.

Tim Cox serves as President of Northland Health Alliance, a rural health Alliance located in North Dakota. The Alliance is a coalition of Catholic-led sponsors which includes 24 healthcare facilities working together to strengthen available resources and capacity to deliver



value-based healthcare in today's competitive market. Tim has been able to secure over \$10 million for members and network programs thought grants and development. Included in those grant dollars are a CAP project, a Community Health Center start up and other diverse

community healthcare development initiatives.

Tim Size has been the Executive
Director of the Rural Wisconsin Health
Cooperative since helping to found it
in 1979. The Cooperative is owned and
operated by thirty-four rural hospitals
with a vision that "Rural Wisconsin
communities will be the healthiest in
America." Tim has an undergraduate



degree in Biomedical Engineering from Duke University and an MBA in Hospital Administration from the University of Chicago. He was awarded a W.K. Kellogg Foundation National Fellowship from 1987 to 1990 and studied Social Entrepreneurship at the Harvard Business School Executive Education Program in the summer of 2009. He is an adjunct member of the faculty of the University of Wisconsin School of Medicine and Public Health.

Tim has long been a national advocate on behalf of rural health and edits a widely read monthly newsletter for RWHC which includes the country's only known rural health policy cartoon series. Among various state appointments in Wisconsin, Tim is on the state's bond authority for hospitals, the Governor's Rural Health Development Council and the Healthy Wisconsin Leadership Institute's steering committee. Among national appointments, he has served twice on the U.S. Department of Health and Human Services' (DHHS) National Advisory Committee on Rural Health and Human Services. He is a past president of the National Rural Health Association and was a member of the Institute of Medicine Committee that wrote Quality Through Collaboration: The Future of Rural Health. He was appointed by the GAO in 2010 to serve on the DHHS CO-OP Plan Advisory Board as part of Federal Health Reform.

FROM THE DESK OF REBECCA J. DAVIS, EXECUTIVE DIRECTOR

April 2012 - Welcome to the 18th NCHN Annual Conference! Since we met last April in Scottsdale, Arizona, NCHN has been quite busy. Each year, when I look back over the past year's events and activities, I am always amazed and so thankful to have the opportunity to work with such a dedicated group of professionals. I thank the members that have volunteered their time and expertise to serve as Directors and Officers of NCHN during 2011. I thank the members that have contributed their time and energy to serving on NCHN's Committees, serving as Executive Coaches, providing support to network leaders by sharing information and knowledge, participating in the Coffee/Tea Chat Program, and finally, for attending this Conference.



During 2011 (May 1, 2011 – April 30, 2012), the NCHN Board of Directors, Officers, and Committees designed programming specifically to meet the needs of our diverse membership. Here is a summary of 2011 accomplishments:

- 2011 NCHN Network Membership: 64 network organizations located in 32 states (an increase of two members from the final count for 2010); seven were new members to NCHN.
- 2. New NCHN Associate Member Program: seven individuals and one organization have joined.
- The NCHN Weekly Update and eNews: electronic distribution continued on a weekly basis. All 2011 editions are archived on the NCHN website.
- 4. NCHN Coffee/Tea Chats: Monthly, one-hour calls allowed NCHN members to connect to discuss whatever is on their minds. The average attendance for the monthly chats has been ten.
- The first NCHN Leadership Summit (September 2011 in Kansas City, MO): A network leadership curriculum was developed and introduced. HRSA Rural Health Network Development Planning Grantees attended and the total registration was 48.
- 6. The NCHN Transformer Leadership Learning Community: The Leadership Learning Community was comprised of NCHN members that attended the Summit. The Community met by conference calls, with a final face-to-face session to be held here at the Conference. This program was a pilot in 2011 and will be fully implemented in 2012, with the 2011 Community continuing to work together and a new 2012 Community forming in September.
- 7. The NCHN Executive Coaching Program: Fourteen members were available to serve as coaches.
- 8. NCHN Quarterly Membership Calls: Topics included Business Planning for Health Networks, Demonstrating Value and Membership Retention, Accountable Care Organizations: The Latest since Scottsdale, Affordable Care Act: A Wisconsin Perspective, and Affordable Care Act What are others doing to prepare for the

- provisions? Average attendance was sixteen.
- Thirty-five (35) questions were posted to the NCHN Listserv from NCHN members. One hundred and eighteen (118) responses were received to the 35 questions.
- 10. One (1) new Business Partner, Tag Healthcare Marketing, was added to the NCHN Business Partner Program. Negotiations are currently underway with the forthcoming announcement of two additional partners.
- II. NCHN continued its presence on Facebook, joined Twitter, and created a Linked-In Group If you are not connecting with your Association on one or all of these electronic formats, please sign up to do so in 2012.
- 12. NCHN was a partner with the National Rural Health Association (NRHA) on the 2012 Policy Institute.
- 13. NCHN committees have been active, with most holding monthly meetings. The majority of NCHN's planning, implementation of new programs, and management of existing member benefits is conducted through the committee system. If you haven't served on a committee before, please consider serving your Association and peers by volunteering for a committee in 2012.
- 14. 2012 Annual Conference: You are reading this report at the 18th Annual Conference of NCHN. At the time of this writing the registration has topped 100! This is the first year that the HRSA Rural Health Network Development Grantees have attended and we are very excited to have them. The conference is co-located with the National Rural Health Association to give NCHN members and guests the opportunity to visit NRHA's large exhibit hall and attend their opening session.
- Finally, in case you missed it, NCHN headquarters (along with your Executive Director) moved to Montrose, Colorado.

Your Officers, Directors and NCHN staff hope that you have realized the full benefit of your membership during 2011 and look forward to working with you to expand membership benefits and program offerings in 2012.
